Schools have a responsibility to hone kids in this regard so that they can become moral members of society. According to the tool argument, students will excel in other subjects, if the students had ethics in school” [7].

From the above mentioned arguments, it becomes obvious that teaching of ethics in educational institutions is the need of the hour, as it is the only source which provides a better life to students.
